Who is Angela Marie Smith?

Angela Smith created an  
“organization” called HEAL  
Online which seems to only  
exist to attack and “shut

claims. And we use the term “their” very loosely, as the organization is mostly comprised of Angela’s independent charades.

For the past several years, HEAL ONLINE (the online presence of HEAL — an acronym for: Human, Earth, Animal, Liberty) has been attempting to give teenagers complete “liberty” from their parents’ authority by making the blanket claim that ALL therapeutic teen programs exist to “brainwash” those who go through them. HEAL also seeks to terrorize countless spiritual organizations with blanket, non-sensical claims like they are “cults”, “frauds” or “brainwashers.” HEAL, run as a University of Washington student organization, was founded by Angela Smith who was

enrolled in a therapeutic program by her parents after attempting suicide as a teenager. **Since then, her goal has been to shut down all therapeutic programs, regardless of their effectiveness, by claiming that all of them are abusive, especially religious ones.**

HEAL believes that religious therapeutic programs are in a conspiracy with the government to “brainwash children AND parents”... It is clear that Angela Smith is merely playing out the unresolved trauma of her youth by seeking to project her pain onto any organization she comes across.
